

White & Case advised on probably the single most important Green Bond of 2020 – The Federal Republic of Germany's EUR6.5bn sovereign Green Bond, which established a benchmark for all EU sovereign green bonds.


Unlike for example France where the majority of issuance has been from the Public Sector, in Germany, Banks and Automobiles & Parts sectors have led the way in Germany.

Green Bonds - German Issuers Classification 2018-2020




